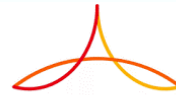

AEO Identifier / Trader Identification Number

- The PSCG welcomes the draft WCO recommendation on the use of identification numbers for AEO to facilitate and improve the functioning of mutual recognition arrangements and thereby increasing the benefits to AEOs
- The PSCG believes that the term “trader identification number” is suggesting a broader scope than just identifying AEOs in an MRA.
- The PSCG urges the WCO that the recommendation focus upon identifying AEOs in MRAs and that the term “TIN” should be replaced by “AEO Identifier”.
